The Outreach Services Department's Mobile Crisis Intervention Service (MCIS) provides crisis intervention services to consumers in the community with the goal of promoting stability, avoiding hospitalization, and ensuring linkage into the traditional mental health system. Services are provided regardless of the consumer's age, race, religion, creed, sex, sexual orientation, disability, mental status, limited English proficiency, ethnicity or national origin. MCIS will ensure the consumer receives the appropriate treatment and services, with the Montgomery County Emergency Service, Inc. (MCES) as back up 24/7. MCIS is licensed by the Department of Public Welfare for individual, team and medical mobile services.

MCIS will address the needs of those who are suffering from mental health, behavior and substance abuse problems or who are dually diagnosed. MCIS will also provide:

- Crisis Intervention
- Interview
- Assessment
- Mobile Medical Services
- Conflict Resolution
- Follow-up Counseling
- Case Management
- Informal Training
- Forensic Diversion
- Referral
- Education and coordination of services with all agencies

MCIS will also act as a liaison or "boundary spanner" between the various systems and agencies that the consumer will be involved with to ensure integration of services and the best possible care and treatment.

Follow-up may include routine visits for one or two weeks to ensure stability, accessing all available resources with referrals to the traditional mental health system for appropriate treatment.

## Other Services Provided by the Outreach Services Department

The Criminal Justice/Forensic component of the department deals directly with individuals who become entangled within the law enforcement and criminal justice system. The department works directly at all levels of the legal system to ensure the individual receives the best possible care and treatment, and when appropriate, diverts that individual away from the criminal justice system back to community-based treatment.

The Mobile Crisis Team also provides intensive case management services to a targeted group of consumers. Consumers will be maintained on the caseload for approximately three months to ensure stability and integration into the traditional mental health system.
